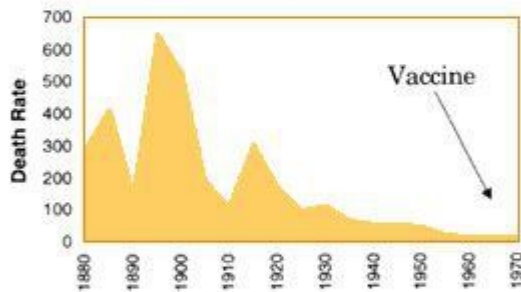

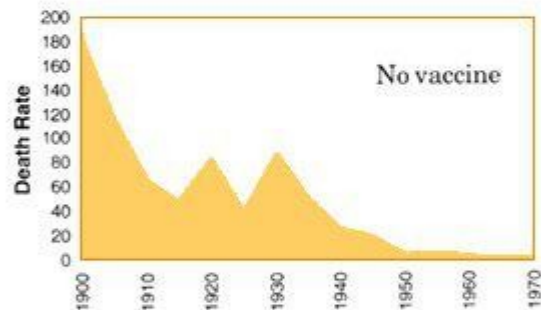
**Diphtheria**



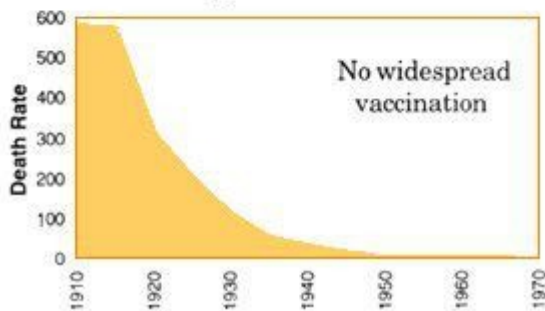

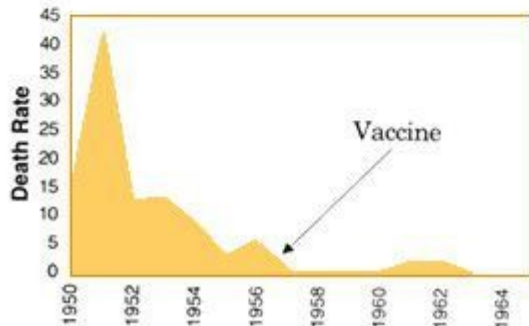

## **THE TRUTH ABOUT THE GERM THEORY OF DISEASE**

I am aware of the work of German scientist Dr. Stefan Lanka who began his pursuit of exposing the germ theory as a false dogma (which proposes that infected humans pass the pathogenic microbes

to infect others) after experimenting with a virus he had isolated, then put into seawater, and observed how it influenced life positively.

Dr. Lanka claimed there is no measles virus and said he would award 100,000 Euros to any scientist who would successfully prove otherwise. A Dr. David Barnards claimed the prize, Dr Lank refused to pay it so they went to court. Dr. Barnards won that case so Dr Lanka appealed.

On appeal, the decision of the German Federal Supreme Court (BGH) presided over by a panel of judges, overturned the earlier lower court decision, was that there was not enough evidence to support the existence of a measles virus after five experts called upon concluded that none of the six scientific papers introduced as evidence for the plaintiff proved evidence of a measles virus from the scientific literature. This was confirmed independently by German laboratories.

The legal results prove that the authors of the six publications in the measles virus case were wrong, and as a direct result all measles virologists are still wrong today, mostly because the original researchers did not run control experiments.

They had misinterpreted ordinary constituents of cells as part of the suspected measles virus and created a composite viral model from separate electron microscopic analyses. The final composite could not be recreated or found in any animal or human. According to Dr. Lanka, this is a common error in the field of virology that attempts to determine pathogenic viruses.

### **VACCINES ARE UNTESTED**

I am aware that the 1980s US legislation exempting vaccine manufacturers from liability also required the US Health and Human Services Department to conduct regular safety tests of vaccines and that in 2019, Robert F Kennedy Jr filed a Freedom of Information request that uncovered no such testing had ever been conducted by that department. I am aware that vaccine makers are exempt from applying the same testing standards to vaccines as drugs as by US law vaccines are not classified as drugs. Consequently no long-term double blind, trials against an inert placebo have been conducted.

I am aware that vaccine manufacturers will often conduct short term trials of a vaccine but not against an inert placebo but against adjuvants which are already known toxins. That has the effect of making the destructive effects of the vaccine. I am aware that while no study has ever been done of the results of administering multiple vaccines at one time, many parents bury dead babies who were fine and healthy before the administration of multiple vaccines.

### **VACCINES CONTAIN TOXINS**

The most significant factor is glyphosate, the active ingredient in the herbicide Roundup. What makes glyphosate so dangerous is that it is pervasive, cumulatively

insidiously toxic, and widely believed to be nearly harmless to humans. Glyphosate collaborates with toxic components in vaccines to destroy neurons. These include, primarily, aluminium, mercury and glutamate. While glyphosate contamination in the food sets up a leaky gut barrier and leaky brain barrier, glyphosate contamination in many vaccines is ominous and likely catastrophic. ### Cancer, Simian Virus 40 (SV40), and Polio Vaccine **Fact Sheet**

- SV40 is a virus found in some species of monkey.
- SV40 was discovered in 1960. Soon afterward, the virus was found in **polio** vaccine.
- More than 98 million Americans received one or more doses of **polio** vaccine from 1955 to 1963 when a proportion of vaccine was contaminated with SV40; it has been estimated that 10–30 million Americans could have received an SV40 contaminated dose of vaccine.
- SV40 virus has been found in certain types of **cancer** in humans, but it has not been determined that SV40 causes these cancers.
- The majority of scientific evidence suggests that SV40-contaminated vaccine did not cause **cancer**; however, some research results are conflicting and more studies are needed.
- **Polio** vaccines being used today do not contain SV40. All of the current evidence indicates that **polio** vaccines have been free of SV40 since 1963.

### Additional Facts

- In the 1950s, rhesus monkey kidney cells, which contain SV40 if the animal is infected, were used in preparing **polio** vaccines. Because SV40 was not discovered until 1960, no one was aware in the 1950s that **polio** vaccine could be contaminated.
- SV40 was found in the injected form of the **polio** vaccine (IPV), not the kind given by mouth (OPV).

I am aware of the research done by arguably the world’s top immunologist, Hugh Fudenberg, MD, and 13th most quoted biologist of our times (nearly 850 papers in peer review journals):  
“If an individual has had 5 consecutive flu shots between 1970 and 1980 (the years studied) his/her

chances of getting Alzheimer's Disease is 10 times higher than if he/she had one, 2 or no shots.”

Dr. Fudenberg said it was due to mercury and aluminium that is in every flu shot. The gradual mercury and aluminium buildup in the brain causes cognitive dysfunction. Flu shots contain 25 micrograms of mercury. One microgram is considered toxic.

I am aware that the Italian vaccine research and advocacy organization [Corvelva](#) recently released new data regarding the use of aborted fetal cell lines in vaccines.

The Corvelva team summarized their findings as follows:

1. The fetal cell line was found to belong to a male fetus.
2. The cell line presents itself in such a way that it is likely to be very old, thus consistent with the declared line of the 1960s.
3. The fetal human DNA represented in this vaccine is a complete individual genome, that is, the genomic DNA of all the chromosomes of an individual is present in the vaccine.
4. The human genomic DNA contained in this vaccine is clearly, undoubtedly abnormal, presenting important inconsistencies with a typical human genome, that is, with that of a healthy individual.
5. 560 genes known to be associated with forms of cancer were tested and all underwent major modifications.
6. There are variations whose consequences are not even known, not yet appearing in the literature, but which still affect genes involved in the induction of human cancer.
7. What is also clearly abnormal is the genome excess showing changes in the number of copies and structural variants.

“Our results greatly reinforce the experimental observations of [Dr. Theresa Deisher](#) and especially the fact that the contaminant fetal DNA present in all samples analyzed in varying quantities (thus uncontrolled) is up to 300 times higher than the limit imposed by the EMA for carcinogenic DNA (10 ng/dose, corresponding to DNA contained in approximately 1000 tumor cells, derived from a statistical calculation, while the precautionary limit is 10 pg/dose), a limit that must also be applied to MRC-5 fetal DNA which inevitably contaminates Priorix tetra. As a consequence, this vaccine should be considered defective and potentially dangerous to human health, in particular to the pediatric population which is much more vulnerable to genetic and autoimmune damage.”

### **VACCINES ARE UNSAFE AND CAUSE HARM**

I am aware that the man who started this vaccine process, Edward Jenner, used his son as a test subject for his vaccine experiments. The son died at age 21 from tuberculosis, which has been linked to the smallpox vaccine.

I am aware that there is a widespread cover up in the medical industry of vaccine caused injuries and deaths thus making objective risk assessment impossible. For instance in Canada it is not possible to report a vaccine reaction as the cause of death on the death certificate and in the 2019 Samoan mass immunisation, adults who died within days of receiving the mandated measles shot are recorded as dying from pneumonia, despite not have coughed at all.

I am aware of the Vaccine Adverse Events Recording System database that lists thousands of adverse events from vaccines from fever all the way through to encephalitis, paralysis and death. I am aware that according to medical authorities as few as 1 in 10 adverse events are recorded in VAERS as many health industry workers do not know of the database or are reluctant to assign vaccines as contributing to a negative health outcome.

I am aware that this makes accurate evaluation of the comparative risks of vaccines versus the infection/disease against which they are promoted to protect impossible to conduct.

I am aware that the US Congress was lobbied by vaccine makers to exempt them from any liability from harm caused by vaccines and that those parents whose children were killed or harmed by vaccines were to apply to the Childhood Vaccine Injury Compensation Tribunal seeking damages. I am aware that, despite the restrictive time frame during which claims can be filed and the fact that only 1 in 5 claims receives compensation, that body has to date paid out over 4 Billion dollars in damages to parents.

I have read the CDC study that shows a 1.8 times increase in neurodegenerative diseases, a 5 fold increase in sleeping disorders and a 6.8 fold increase in autism to vaccinated versus unvaccinated children. I am aware that many scientists have established the connection between nerve and brain damage and vaccines.

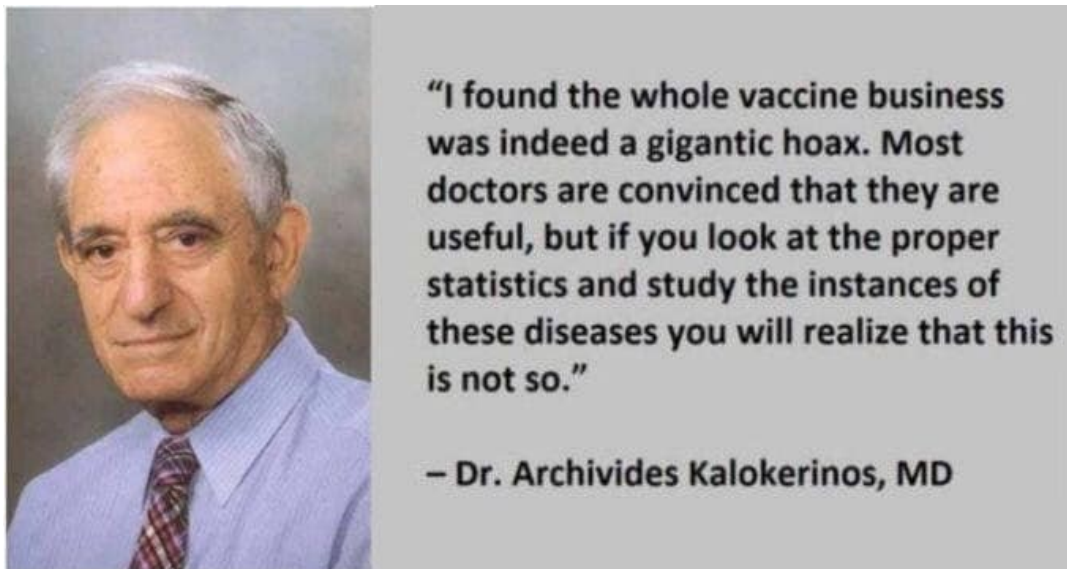

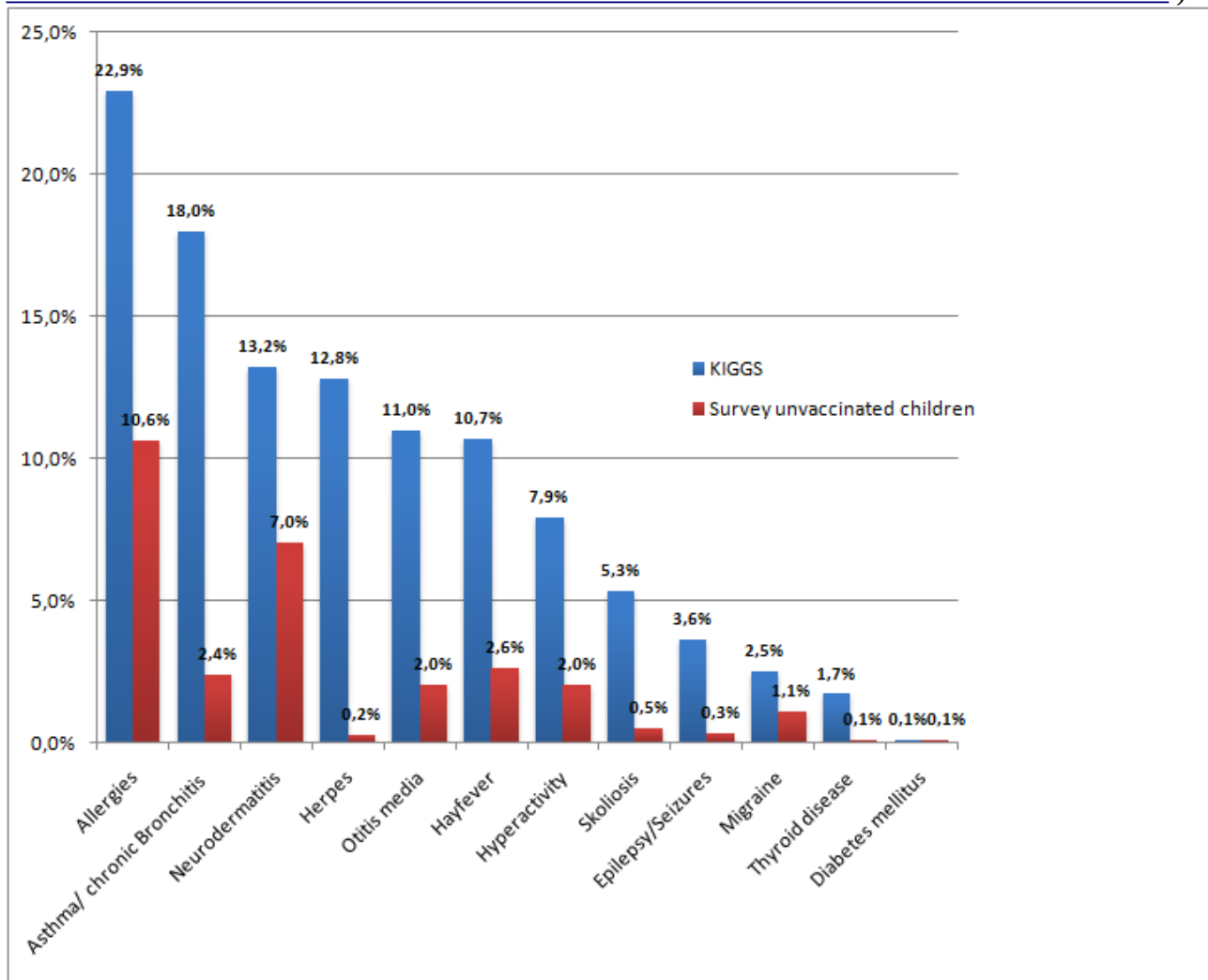
I have watched the film VAXXED and am fully aware of the negligence and misconduct surrounding the manufacture and promotion of vaccines.

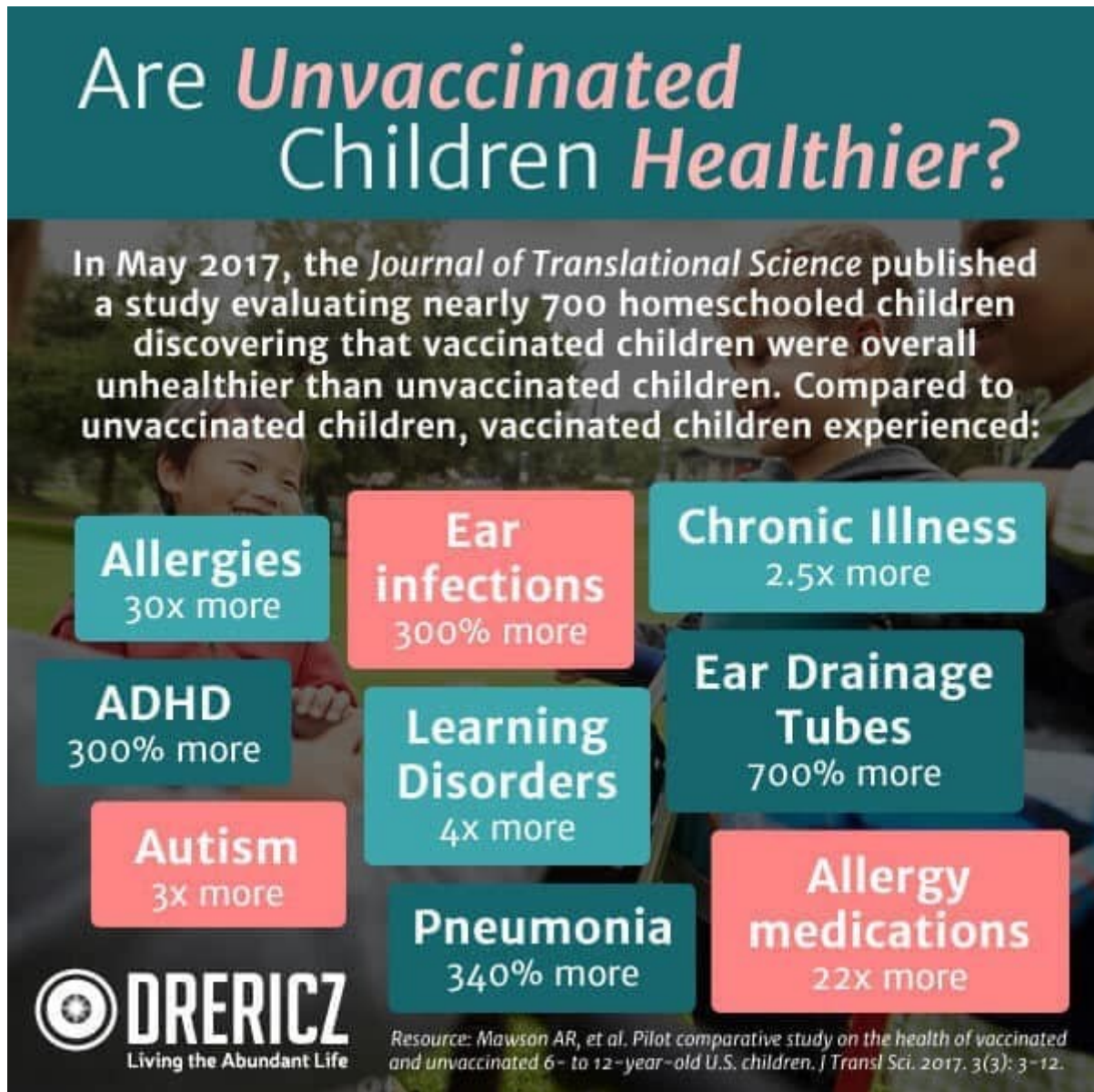

To isolate the virus, they first went to Iceland and dug up the long dead and frozen sheep. After the war, many German scientists came to America under Operation Paperclip and continued their work.

The American space program was initiated in this manner. February 12, 1962, saw the birth of America's "Special Virus Program." In 1969, biological warfare expert Donald M. MacArthur predicted that a biological agent would be developed within the decade, that would destroy its victim's immune system.

On June 9, 1969, at a House Appropriations hearing, the Defense Department's Biological Warfare Division requested funds to create this new biological disease, the "Special Virus." It was stated that the new weapon would be a disease created by splicing certain genes and would affect the victim's immune system. It was stated that they were five to ten years from project completion. The funds were approved.

On July 18, President Nixon sent a secret memo to Congress entitled "Special Message to Congress on Problems of Population Growth" regarding an "urgent overpopulation" problem. March 16, 1970, President Nixon signed Public Law 91-213 into effect. Here we are told that the population growth of the third world is seen as a threat to U.S. investment opportunities. It was then documented that a solution "To Stabilize World Population" would be sought. John D. Rockefeller III was called to be chairman of the Commission. This same issue of population control is emphasized in Nixon's July 18, 1969, "Message to Congress on Population" and House Resolution 15090, part IV. page 129 makes mention of a mysterious "Synthetic Biological Agent."

In 1971, Dr. Robert Gallo wrote a paper on the "Special Virus", titled "Reverse Transcriptase of Type-C Virus Particles of Human Origin", in which he reveals he was working on behalf of the U.S. government to create a virus that would negatively impact the defense systems of the human immune system. We are told that, as part of the program, the Visna virus, a form of wasting disease the Nazis found in Icelandic sheep, was spliced into another to create this Special Virus particle.

In 1972, the World Health Organization (WHO) stated that: "An attempt should be made to ascertain whether viruses can in fact exert selective effects on immune function. By depressing 7S vs. 19S antibody or effecting T-cell as opposed to B-cell function... the possibility should be looked into that the immune response to the virus may itself be impaired if the effective viruses damage more or less selectively the cells responding to the viral antigens." - Bulletin of the WHO, vol.47. pg. 257- 274.

In 1974 we saw the American government release "NSM-200 U.S. Plan to Address Over Population." It was the sole topic of discussion at the World Population Conference held in Bucharest Romania later that year. In 1975, President Gerald Ford signed National Security Defense Memorandum #314 (NSDM#34). This gave official U.S. approval for the enactment of Kissinger's NSSM-200 depopulation program.

An experimental hepatitis B vaccine ("Lot#751"), made by Merck and Co. Inc, was tested exclusively on homosexual men in Manhattan beginning in 1978. Soon after, the vaccine was also tested on the same population in Los Angeles and San Francisco. These tests were overseen by Dr. Wolf Szmunes who was working for the Centre for Disease Control (CDC), testing lasted until 1981.

In 1984, Dr. Robert Gallo filed a patent application for the invention of the HIV/AIDS virus. U.S. patent number 4647773. <https://patents.google.com/patent/US4647773A/en> In order to patent a biological organism it would have to have been genetically modified or engineered. Over the next five to ten years, the world saw the outbreak of the AIDS virus; the epicenter being among Manhattan's, Los Angeles' and San Francisco's gay populations. Coincidentally, the exact same people who received the hepatitis B vaccine were the first AIDS victims.

The 1984 “discovery” of AIDS was announced by Dr. Robert Gallo of the National Cancer Institute, which is located on the grounds of Fort Detrick, Maryland. This is the main U.S. Army biological weapons research facility. His paper announcing the discovery was nearly word for word identical to his earlier 1971 paper which told of his search for the "Special Virus." This announcement made Gallo the most famous virologist in the world. In Vol. 27 of Science, on pages 173-177, Dr. Robert Gallo announced that HIV/AIDS in fact “evolved from Visna” and has the exact genetic sequences. Despite this, the world has been told that the virus came from infected monkeys in Africa. If HIV/AIDS came from African monkeys, we must ask how they got it from long dead Icelandic sheep? The world is told that AIDS is the first primate virus to “jump species”, to cross from monkey to man. It was also discovered that the incidence of AIDS infections in Africa coincided exactly with the locations of the WHO smallpox vaccination program. The London Times. May 11m 1987, ran a headline for an article by Pearce Wright, Science Editor, which read "Smallpox Vaccine Triggered AIDS Virus.”

In 1999, Dr. Boyd E. Graves, himself an HIV patient, was researching AIDS when he found a document that seems to prove that the American government invented the disease as a biological weapon. The document is a five-page fold out flowchart that was originally page 61 of a volume called "the Special Virus Cancer Programs, a division of United States' bio-wcaponry, 1971 Progress Report #8." The flow chart links together fifteen animal reports, 20,000 scientific papers and numerous contracts. The objective of the flowchart was the creation of a “contagious cancer virus” that would attack the immune system, exactly what HIV/AIDS is. With this knowledge, Graves filed suit against the United States for the “creation, production and proliferation of AIDS” on September 28, 1998. Both the lower court and the appeals court dismissed the case as “frivolous”. Graves has since written of his work in his book State Origin: the Evidence of the Laboratory Birth of AIDS, in which he discloses hundreds of other incriminating government documents.

The American government spent \$550 million to develop the "Special Virus". Despite calls to account for the money and release information about this virus, they have refused. According to Dr. Graves. 15,000 gallons of the AIDS virus was ready in 1977. From that point it was distributed to Africa disguised as a small pox vaccine and then in Manhattan, distributed as a hepatitis B vaccine for gay men. Blacks and gays: two of the most discriminated against groups in the 1970-80's. Startlingly, the AIDS virus is ethno-selective, infecting twice as many Blacks, Latinos and Native Americans as whites, with death coming three times as swiftly. On April 20, 2000, the Washington Post reported that 16 million people had died from AIDS since 1980. Sixty percent of the dead are sub-Saharan Africans and in the United States more than 80% of those killed by AIDS have been African Americans.

With the heat on him, in 2001 Dr. Gallo admitted he was the "Project Officer" for the federal virus development program, aka the “Special Virus.” He said his work was on a primate study contracted by Litton Bionetics that combined cancers and viruses in baby macaque monkeys. Few understand that AIDS is a form of cancer and fewer yet understand the relation between cancers and viruses.

The Washington Times reported on September 21, 2003, that “Some of the Polio Vaccine given to millions of American children from 1962 until 2000 could have been contaminated with a monkey virus that shows up in some cancers, according to documents and testimony to be delivered to a House committee Wednesday." This cancerous monkey virus, known as SV40, was injected into millions of North American children between 1962-2000. This generation now has the highest incidence of cancer, an extremely expensive disease to treat.

AIDS was created to kill millions of people. The Luciferian elite made themselves judge, jury and executioner. The victim's supposed crimes? Mere existence. Consider that public health clinics

continue to attract mainly poor and marginalized minority groups for free immunizations and vaccines. For these reasons we should be wary of mandatory vaccination programs that just don't make sense. In 1998 President Bill Clinton enacted legislation that 12 hour old infants receive a series of three vaccinations against Hep B. Why? Merck, was head of America's biological weapons industry during the Cold War.

# 1960s vaccination program blamed for sudden wave of measles in infants

BOSTON (AP) — A generation ago, doctors routinely began vaccinating every child against measles. No one worried much what would happen when they grew up and had babies of their own.

In hindsight, perhaps they should have: These new mothers fail to pass on the strong resistance to measles at birth that an eternity of women before them have done.

The result is a new problem — measles in the very young.

This unforeseen byproduct of a well-meaning public health campaign has become apparent over the past two or three years, as larger numbers of vaccinated women have reached their childbearing years. Because the mothers got vaccinated, their babies are unusually susceptible to measles in their first year of life, when it is a potentially life-threatening disease.

Now, more than one-quarter of all U.S. measles victims are under a year old, an age when this disease was once almost unheard of.

"It's an extremely interesting phenomenon and one of great concern," said Dr. William Atkinson of the U.S. Centers for Disease Control and Prevention

to change. In 1985, almost 8 percent of measles cases were in infants under age 1. By 1991, it had climbed to 19 percent. And so far this year, 28 percent of all measles cases have occurred in babies under a year of age.

Measles is especially hazardous in infants because of the risk of complications. Between a quarter and a third develop some related problem, such as diarrhea, ear infections, pneumonia or encephalitis.

"It is a problem. But if we did everything else right, it would not be a problem," said Dr. James Cherry of the University of California, Los Angeles.

If the highly contagious measles virus was not circulating, it would not matter if babies were susceptible a few months sooner. But the virus is not quite under control. Cherry and other experts say the reason is too little use of the vaccine among preschool children.

CDC guidelines recommend that babies get their first measles shot at 15 months and a second between ages 4 and 6. Every child must be vaccinated to attend school.

However, in some cities only about half of all 2-year-olds have been vaccinated. It is these
